



# National Emergency Grant Employer Survey

Workforce Solutions Golden Crescent has received a National Emergency Grant (NEG) as a result of Hurricane Harvey. The grant funds are to assist affected individuals that reside in areas affected by Hurricane Harvey from August 25, 2017, and continuing with employment and training. Only Public and non-profits are able to utilize eligible workers for hurricane cleanup and recovery including humanitarian assistance within the disaster areas. Pay for the temporary positions will be the normal wage of employees with the same experience, education and skill level. Pay increases will follow the same policy as regular employees. Workforce Solutions Golden Crescent will utilize a third party vendor to cover workers compensation and wages for the eligible workers. The eligible workers are allowed overtime hours equal to regular employees. **The workers can work a maximum of 12 months OR 2,080 hours through the NEG program.**
